Hereby California All Steel Carports Inc. agrees to pay the dealer 10% commission for the sale of any carport/barn/garage/ etc. sold by the dealer. The 10% commission is for the total sales price excluding the tax. California All Steel Carports Inc. is responsible for filing the taxes with the local and state agencies. The 10% commission will be the maximum down payment made by a customer and taken by the dealer for his/her commission. No dealer will take more than 10% commission without the written consent of California All Steel Carports Inc. in Fresno, CA. When a sale is made and paid in full at time of purchase, the payment will be made to California All Steel Carports Inc. in Fresno, CA. California All Steel Carports Inc. will then send the dealer a check for the 10% commission. If the dealer collects a full payment or partial payment above the 10%, unless otherwise agreed in writing, he/ she may incur legal fees and court costs if necessary to recover this unauthorized money taken by the dealer. All of the orders sent to California All Steel Carports Inc. with price or payment discrepancies may be held on hold until payment or price is resolved. California All Steel Carports Inc. will be responsible for collecting all balances due for carport/barn/garage orders payable by Visa, MasterCard, or Discover. Also, any cashier's check or money order will be made to California All Steel Carports Inc. of Fresno, CA. NO PERSONAL CHECKS WILL BE ACCEPTED FOR BALANCES DUE.

The above named dealer agrees not to sell carports/barns/garages for any other company other than California All Steel Carports Inc. in Fresno, CA. However the dealer may sell for another company with the written consent of California All Steel Carports Inc. in Fresno, CA. Displays with exclusive property of California All Steel Carports Inc. in Fresno, CA will be provided at no charge to the dealer and are for the purpose of display only. Displays must not be moved or altered in any way, added to, or removed without the written consent of California All Steel Carports Inc. in Fresno, CA. California All Steel Carports Inc. will not be responsible for liability of damage of any display that may be placed on the dealer's lot. California All Steel Carports Inc. in Fresno, CA reserves the right to cancel this dealer contract and remove the displays without notice due to improper business practice, no sales, or violation of this agreement. The dealer must give California All Steel Carports Inc. a 30 day minimum notice to remove any displays when he/she terminates the dealer agreement for any reason. The displays, which remain exclusive property of California All Steel Carports Inc., provided to the dealer at no cost, shall not and cannot become part of any lien of claim including bankruptcy, by the above named dealer or landlord of the above stated address. Any display(s) being picked up the California All Steel Carports Inc. in Fresno, CA is understood to be so, without legal contest, by the dealer or landlord. The dealer or landlord may incur legal fees and court costs if necessary to recover the displays, or if the displays are sold or removed from the dealer's lot without written consent of California All Steel Carports Inc. of Fresno, CA.
